1. Name, seat, legal capacity, financial year

The association has the name Woman-Can
He is based in Germany, 56424 Ebernhahn, Schubertstrasse 18 He is to be registered in the association register.
The financial year is the calendar year.
2. Purpose, non -profitness

The purpose of the association is the support of single parents, not married mothers with their children through public relations and care. The purpose of the articles of association is realized in particular through financial support for mothers and their children.

The association pursues exclusively and directly non -profit purposes in the sense of the section "tax -privileged purposes" of the tax code. The association is selflessly active, it does not primarily pursue self -economic purposes. The association may only be used for the statutory purposes. The members do not receive payments from the association. No person may be favored by expenses that are foreign to the purpose of the corporation or are favored by disproportionately high remuneration. Within the framework of the budgetary possibilities of the association, the activity of the members of the board, insofar as they do not receive any payments on the basis of a service contract, can be paid against payment of an allowance that is not exceeded in its applicable version according to § 3 Section 26a of the income tax law, to be exercised. The board makes the decision about a fee based association activity. The same applies to the contract content and the termination of the contract.

## 3. Acquisition of membership

Anyone aged 18 and over can become a member. The board decides on the written application for admission. Minors require the approval of the legal representative.

## 4. Membership termination

The resignation from the association is permitted by the written declaration to the board with a notice period of three months at the end of the financial year.
A member can be excluded from the association if his behavior gives you in a greater way against the interests of the association. The board decides on the exclusion.
5. Post

An amount is raised whose amount is set by the general assembly.

## 6. Organs of the association

Organs of the association are the board and the general assembly.

7th board
The board consists of:
a) 1st chairman
b) 2nd chairman
c) Secretary
d) treasurer

The board is appointed by the general assembly for a period of two years. However, it remains in office until the effective order of a new board. The positions are to be made individually. It is chosen who receives the simple majority of the votes. Conservation are not taken into account. If a member of the board is eliminated prematurely, the rest of the board is authorized to appoint a replacement member until the new general assembly is reorganized. The association becomes court and out of court (§ 26 BGB) by the

1st chairman and the 2nd chairman. Everyone is entitled to represent a sole representation. The power of representation of the board is unlimited to the outside world. Interior ratio is determined that the 2nd chairman is only entitled to represent the association if the first chairman is prevented. For legal transactions from a business value of EUR, the prior consent of the general assembly must be obtained internally. Decisions of the board are made with a simple majority. Conservation are not taken into account.

## 8th general meeting

The general meeting takes place annually in the first quarter of the year. A general meeting must also be convened if the interest of the association requires this, or if the convening of a tenth of all members, stating the purpose and the reasons, is requested by the board. Each general meeting is from
1st chair, if he was prevented by the 2nd chair and if he was prevented by another board member. The convening is carried out in text form with a period of two weeks. The deadline begins with the shipment to the recently announced contact address of the member. With the invitation, the agenda stipulated by the board must be informed. The general assembly is headed by the 1st chairman, if he was prevented by the 2nd chairman. If this is also prevented, ordered the
General assembly a meeting manager. Each general meeting is quorate regardless of the number of members. Unless otherwise determine the law or articles of association, the majority of the valid votes cast decides when passing the resolution.
Conservation are not taken into account. Every adult member is entitled to vote. A transfer of voting rights is not permitted. The type of vote is generally determined by the chairman. At the request of a third of the members published, the vote will be made in writing.

## 9. Protocols

The protocol leader (protocols) must be prepared for the course of the board meetings and the general meetings. The protocol is created by the secretary. If no secretary has been appointed or if
this is prevented, a protocol leader must be elected at the beginning of the meeting. The protocols are to be signed by the protocol leader and the chairman.

## 10th amendment

To change the statutes, the majority of three four parts of the released members are required. Conservation are not taken into account. The consent of all members is required to change the association's purpose. Non -disadvantage members must agree in writing. At least the points of the statutes affected by the change must be specified in the agenda. A new version can only be decided if it was called such on the agenda. Changes in the articles of association, which are necessary due to complaints from the statutes by the tax office or the register court, can also be decided by the board. The members are of amendments to the articles of association
to be informed in writing immediately.

## 11. Dealing

The dissolution of the association can only be decided in a general assembly specially called for this purpose with three four parts of the published members. Conservation are not taken into account. If the association is dissolved or the elimination of its non -profit purpose, the assets of the association (precisely designated corporation under public law or a other tax -privileged corporation) which the assets of the association must use directly and exclusively for charitable, charitable or church purposes.

Addition: jurisdiction is Montabaur; The place of performance is Ebernhahn.
